

NOTICE TO EXHIBITORS

- * This trial is open to all dogs registered with the UKC, 6 month of age or older.
- * Trial will be judged under the current regulations (1/01/2009) of the United Kennel Club. Request rules from UKC at 100 E. Kilgore Rd., Kalamazoo, MI 49002 or <http://www.ukcdogs.com>.
- * All dogs must be on-leash or confined when not competing.
- * Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the show committee.
- * It is expressly understood that exhibitors alone are responsible for the behavior of their dog(s) and /or children. Any exhibitor whose dog(s) and /or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the show committee, be asked to leave the show site. In that case, no refund of any fees paid will be made.
- * Entry fees shall not be refunded in the event that the dog is absent, disqualified or excused by the Judge or Show Veterinarian. No entry fee will be refunded if the trial cannot open or be completed by reason of riots civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.
- * Exhibitors are responsible for complete, accurate, and legible information on the entry forms: illegible or incomplete entries cannot be entered in the show.

DIRECTIONS TO THE SHOW SITE: From I-80 East or West, take I-29 South.

From I-29 North or South, take the "Lake Manawa/IA School for the Deaf(East IA-92) via Exit #47. Turn RIGHT (south) US-275 (US-275 becomes WABASH AVE) go 2.2 miles. Turn LEFT onto PIONEER TRIAL (JCT G66 county road) for 4 miles. Turn RIGHT onto 240TH ST which is a gravel road just past signs for Hyde Park & Mormon Trial Park. You will travel 1.2 miles south on 240th St., and it is the 4th house on the right, just after you cross a bike trail: 11092 240th St. Please park on the concrete drive across from the vet clinic.

TRIAL SITE: The trial will be held in an indoor air-conditioned building. Crating space is limited so please bring appropriate shade cover for those wishing to crate outdoors. A CPE agility trial will be held outdoors at this site. Food will be available for purchase.
